Woerth gave the parks report. Wheeldon gave the streets report. Fish gave the water/wastewater report and Sailors gave the clerks report.

Chairman Johnson mentioned the letter recently mailed to village citizens by the board. She said it was a friendly reminder to keep up your property.

In old business the village presented two bids for the Town Hall repairs and windows and the Gazebo repair at Capital Square Park. Motion by Woerth, second by Wheeldon to accept the bid by Sunrise Construction for the repairs. Fish yes, Wheeldon yes, Johnson yes, Lokke yes, Woerth yes. Motion carried. The clerk will contact the bidders and inquire when Sunrise Construction can start on the project.

Motion by Woerth, Second by Lokke to purchase a defibrillator and first aid kit for the Village. Wheeldon yes, Fish yes, Lokke yes, Woerth yes, Johnson yes. Motion carried. The clerk will check for rules concerning where the defibrillator can be placed for the public use.

Motion by Woerth, second by Fish to contact JEO to pursue the funding for the 3rd Street bridge. Lokke yes, Woerth yes, Johnson yes, Wheeldon yes, Fish yes. Motion carried.

Motion by Wheeldon, second by Fish to close the west half of 7th Street from Allen Street to the Highway 136 right of way. Johnson yes, Woerth yes, Fish yes, Lokke yes, Wheeldon yes. Motion carried.

The approval of the Internal Control Policy was postponed.

In new business Paul Fish stated that Randy Hellbusch had been contacted to perform a water rate survey. The survey was completed and it was discovered the water department had a \$17,000.00 deficit. The Village is currently charging \$18.00 for the first 1000 gallons of water used and \$4.75 per 1000 gallons used thereafter. The recommended proposal was that the Village raise their rate to \$25.00 for the first 1000 gallons of usage and charge \$5.00 per 1000 gallons used thereafter. Motion by Woerth, Second by Lokke to post a flyer about the proposed water rate increase and reasons for the proposed raise in rates. Lokke yes, Woerth yes, Johnson yes, Wheeldon yes and Fish yes. Motion carried. The increase with be revisited at the next meeting on June 10, 2025.

Fish gave a report on the alarm system at the water tower. He said that we have not had an alarm connected for approximately 2 years. HOA Solutions came and looked at the tower and gave 3 different proposals for the alarm system. Motion by Fish, second by Wheeldon to select option 2 at a cost of \$1948.00 to the Village. Wheeldon yes, Fish yes, Lokke yes, Woerth yes, Johnson yes. Motion approved.

Motion by Woerth, second by Fish to approve the amendment to extend the general administration contract with SENDD for the 21PW004 project. Fish yes, Wheeldon yes, Johnson yes, Lokke yes, Woerth yes. Motion approved.

Motion by Woerth, second by Lokke to approve the amendment to extend the construction management contract with SENDD for the 21PW004 project. Woerth yes, Lokke yes, Wheeldon yes, Fish yes, Johnson yes. Motion carried.

Motion by Woerth, second by Lokke to approve the building permit for 705 Allen Street. Johnson yes, Woerth yes, Fish yes, Lokke yes, Wheeldon yes. Motion carried.

Motion by Wheeldon, second by Fish to approve the facilities use policy as written. Woerth yes, Lokke yes, Wheeldon yes, Fish yes, Johnson yes. Motion carried.

The ordinance review was postponed until the June 10, 2025 meeting. Woerth will discuss the trailer ordinance at that meeting.

The bank account consolidation/quick books structure was postponed. Jamie Aue will facilitate the setup of the quick books online.

Motion by Wheeldon, second by Fish to approve the bid from Affordable Asphalt to do the repairs to the village streets. Fish yes, Wheeldon yes, Johnson yes, Lokke yes, Woerth yes. Motion carried. Wheeldon will contact the vendor to discuss the streets the Village wishes to repair this year and a possible start date.

Motion by Wheeldon, second by Lokke to approve the building permit for 618 Main Street, contingent on the property owner supplying a survey showing that the building will be at least 8 feet from the property line. Woerth yes, Lokke yes, Wheeldon yes, Fish yes, Johnson yes. Motion carried.

Motion by Woerth, second by Wheeldon to approve the tobacco permit for the Brownville Market. Lokke yes, Woerth yes, Johnson yes, Wheeldon yes, Fish yes. Motion carried.
